III. Treasurer's Report - Wu

- Ross questioned whether there was appropriate authorization for expenditures, as Wu indicated there has not been a meeting of the Buffalo board since 2019. Further investigation was requested.
 - o Buffalo \$3,000 expenditure for referee gifts
 - Tournament Food
 - Venmo dues transactions

IV. SRA Report (Tata)

- Recertification Needs:
 - o Referee no surprise here
 - Assessor asked Steve Montanino to work on a recertification course similar to the Mentor course
 - o Instructor Tom will be putting something together
 - Assignor suggest a Zoom session for simplicity
- Law Firm
 - o We are heavy in the era of litigation, and we need to be prepared
 - Need counsel on tax law and employment law

- o NYSWYSA uses Gross Shuman firm (Buffalo, NY)
- Civil and criminal attorneys; no tax counsel
- o \$360/hour; maybe less depending on service requested

• Insurance

- New general liability certificate sent to DRAs and directors
- May need to consider data breach liability coverage
 - OMS
 - US Soccer and LC
 - Game Officials
 - Spreadsheets

• Registration Status

- o 2022 finished with 912 referee registrations compared to 2021 with 869
- Syracuse and Ithaca saw fewer in 2022 than 2021
- Rochester has the most registered
- SMF to remain at \$15
- o If numbers increase to 1,200+ we should be able to roll back to \$10
- The \$15 would have been required this season, but we were able to operate relatively
- Coordinator of Referee Development (CRD)
 - Steve Montanino to hold this position
 - o Responsible for implementing a statewide mentor program

• State Director of Assessment

- Will remain vacant until we have clearer picture/understanding from national
- o SRA will continue to hold position
- Steve Montanino will assist in some of the SDA duties

• Chairperson

- Difficult position to cover as the role has little administrative duties and vote
- o If anyone knows of someone willing to be chair, let Michael know

Elmira DRA

- Blair Sibley will not be returning for a new term
- Chad Sustello has agreed to reclaim the DRA position now that the reason of his resignation have been remedied.
- We have a referee who has been sanctioned by the Center for SafeSport from a USASA sanctioned event. It has been a year since the incident occurred. We do not have any additional details. Sanction comes directly from SafeSport

V. NYSWYSA (Brame)

- Up to 48,000 players at end of 2022 season (-4k from pre-Covid)
- US Club, Girls Academy, MLS Next, DPL, etc... Many new organizations which we will be serving
- Will be starting to reach out to Colleges and Universities (20-30 schools) about recruiting referees in next few weeks. 1-2hr presentation at each school, esp club, intramural players

VI. SYRA Report (Campbell)

- State Cup Went relatively well, but ended up short 4 referees. Good feedback
- Young Referee of the Year Sent 70-80 invites, got 3 male applicants and no female applicants. Re-checking for female applicants
- Assigning system experimenting with Stack Officials, not going well. Will be meeting with Sales/Engineering next week to update on issues/needed enhancements – We are requesting that Stack Sports not sunset GameOfficials in March 2023

VII. SDI Report (Ross)

- Recert clinics/training
 - With Entry Class changes, basic re-cert will shift to be more basic

- All Regional, Adv Grassroots, Emeritus referees must complete advanced recert. Recommend that Grassroots with more than a few years experience also complete advanced recert
- Any district wishing to hold advanced recert clinics needs to give number of clinics needed to Ross in next week

• Entry Level Referee courses

- o Sooner we get courses scheduled, the sooner we can start recruiting
- o Need facility that allows both classroom and "field" instruction
- Clubs can request/host sessions they are responsible to provide suitable location and coordinate communications to their learners

Referee Mentor

- o 2022 class limited to instructor-assessors
- Going forward, first priority goes to those who are instructors or assessors

Instructors

 Considering keeping local instructors (not USSF registered) with registration fees 100% to state

Registration

- Will be set up in near future
- Inclined to require valid SafeSport prior to allowing registration (configured in OMS)
- Hair adornments will be covered in re-certs based on HS changes and 2022 complaint

VIII. SDA Report (Tata)

- Only 1 referee did not get the required recert assessment (will be issued waiver)
- We are short assessors
- GameOfficials was broken making it difficult to get feedback to referees
- Assessors also delayed completing assessments in a timely manner

IX. SCA Report (Haller)

- Assignor Guidance document is in process and will add legal review
- DRAs should expect email in next week requesting status of assigning needs to determine whether Assignor course is necessary

X. Binghamton (Pitcher)

- All games covered in spring season with 1 or more referees (not always full crews)
- Seeking location for Entry Level classes

XI. Buffalo (Helwig)

• Would like to increase number of advanced recerts

XII. Elmira (Sustello)

Recruiting questions: If referee candidates are too young, how should we handle?
Must be 13 years of age to register by Jan 1 of reg year. We would rather avoid steering people to non-affiliated groups to get these kids started

XIII. Ithaca (Campbell)

- Trying to cover all games with about 10 active referees (or 35 total)
- Spring, everything covered with at least 1 referee. May not be able to cover all fall games

XIV. Rochester (Bianchi)

• Nothing new from board – Board currently has no president

XV. Southern Tier (Phearsdorf)

• Covering 3 leagues with 45 referees makes things tight. Leagues use both GO and Arbiter which has been difficult for referees
