## Michael Tata; SRA

- Referees out of uniform: Please be familiar with US Soccer policy, our policies and our bylaws
- We do review our policies in August with the executive board and in September with the entire club. They are available with the secretary and on our website
- Finances are very good
- Registrations were uploaded twice (another problem with US Soccer's program money will be refunded to us
- There may possibly be some dormant funds refunded to the club further details will be forthcoming
- Assessors and Assignors have not been uploaded to national they will go in the next upload
- Is very apprehensive about Arbiter will have further discussion with the executive board
  - While it is a problem with Arbiter, US Soccer is not helping them
  - o The new system is very difficult to search and use
- Eric Bryant is the new Batavia DRA; he is a dentist from Perry

- AGM annual general meeting met with Lauren Dearman to get some ideas (coordinator)
  - o Gave her some ideas of districts to hold it in
  - She is based in Rochester
  - Courses, training (directly and indirectly), social events
  - Friday evening until Sunday noon event
  - Topics to include: Nutrition and fitness, finances, FIFA panel, awards luncheon for district to recognize referees, dinner with main guest speaker (Saturday evening); swag bags (welcome goodies), official sports to be on site one day, assessor meeting, assignor meeting, district member meeting, etc.
  - Lauren will appoint a committee to work on these events
  - If you have any ideas, please communicate these
- Registrations 1387 (approx) with another upload coming through
  - Last year 2180 all badges
- What does the DRA do? DRA primary responsibility registrations! Registering the referees each year; recruitment, recertification and registration!
  - Liaison with the SRC and local area
  - Mediator should not have a vote on the local board as you are the mediator for disputes prior to coming to SRC (your vote is with SRC)
- Grant money for mentoring is still available let Michael know what the districts need
  - Lisa Augustine sent presentation to Michael (not received)
- Buffalo has a state referee who has completed all requirements but has not taken the fitness test - - is there anyone who has a fitness test in their district?
  - A district is free to schedule another fitness test if required; but will be for anyone in the state
- Tom set up an academy 2 years ago with the Greece Cobra there is a US Youth soccer Emeritus
  cup at the end of July recreational club tournament it is in Churchville the Rochester
  referee unit will send in some referees. He would like to make this an academy. They would
  like to make this a charitable event in honor of Michael's daughter and add to the title "...and
  the Lydia Tata tournament"
  - We will invite referees and pay a flat fee (not per game fee)
  - Dinner Saturday evening
  - Bring in assessors (to help qualify for D&G)(SRC will cover the cost)
  - Club will donate in Lydia's honor
  - July 17 18 19
  - o There are more logistics to work out (accommodations, etc) SRC to cover the cost
  - o There is only 2 rec tournaments in the Rochester area (the hot dog cup in Chili)
  - o Will probably work with the Rochester Referees but if you have anyone, contact Michael

## Bill Campbell; SYRA

- Will post tournaments on our website for the state
- Region 1 is a mess!
  - Everyone is new to the job!
  - We are working through the issues; please be patient
- Regional's
  - Made appointment for presidents cup -had 3 turn downs
  - ODP has all but 2 people, 4-5 turn downs
  - Champion league finals invited 4, 1 turn down

- o Regional championships 8 accepted, 5 turn down
- State cup invitations going out middle of the week
  - o If you want to send additional people, please contact Bill by Tuesday this week
  - DRA's when Bill sends out the invitations, please send to the referees and ask them when they get the invites, please communicate to Bill that they received the email
  - State cup deadline to reply is April 27<sup>th</sup> so he has a few days to fill the turn backs (need 54)
  - Please make sure that they are eligible
- When can we expect the next list of risk management candidates? The next download to USSF will occur within the next 10 days and then Bill will send it in for a new list
- If the referees say that they have the risk management pass but are on the "No" list, they must demonstrate that they have risk management give Bill a list to investigate and get corrected Note: the referees should have applied in December!
- President's cup is Memorial day weekend

## John Kramer; SAC

- Is getting a list from NYSW as to are the tournament assignors will send list to DRA's so that they can send assignors
  - This will help with the D&G assessments
- Has sent out an email to all assignors
  - Still getting email questions concerning ranking
  - If you are not ranking your referees within the district it is a problem
  - Not sure if Rochester has had a ranking meeting this year
  - RDSL has decided to use their own assignors
- Has heard a complaint about referees not wearing proper uniforms it is within the policies if the assessor sees this it must be noted as a deficiency
  - Since this is an ongoing problem with this particular referee, this referee must not be assigned a game until he is properly attired
- Has been struggling with official sports poor supply of uniforms since the end of January as
  they have had a problem with their supplier -they hope to get this rectified by mid May
- If assignors have problems, see John
- An email will be sent to all upgrade candidates

# Art Jaspe; SDA

- Contracts were fulfilled with referees and assessors
- Have completed those assessments which were lacking in arbiter
- The assessment assignments will be sent to Bill for posting after the meeting today
- Used both Arbiter and Bill's last spreadsheet to get as complete a list as possible
- Upgrade list is available
- Assessment process for this year is on its way
  - o ODP Sam and Dick
  - Regional's Dick and Art
- Sent a request that each assessor does 5 D&G each season on young referees
  - We have yet to identify our young referees that we should be watching closely

- This is an identification of the referee's personality and ability at a young level to determine their potential
- This is 5-6 hours of the assessor's time for the season as part of their requirement
- o Find these games at tournaments or a house league game
- o This can help to build a pool of young referees
- They will not be assigned by Art
- If the assessor does not complete this requirement they will not get registered for the next season - this will be part of the next email and allow them to understand the rationale that this is part of the recert for the 2015 badge
- There is not a requirement to leave the assessor's home area to complete these D&G's
  - If a district requires a mileage program (Syracuse to Watertown) or any other special needs to complete this requirement, please discuss this with Art
- Art can also reach out to the assessors to help make themselves available to the neighboring districts to complete this requirement
- Optimum age grade 8 under 18 years of age, at least 3-4 years of service (remember minimum years of service for state cup is 3 years)
