IV. SRA Report (Tata)

- There have been requests to review WNYSRA financials. Would like to provide a view-only opportunity in-person.
 - o Ross Are members not entitled to copies of the Treas report?
 - Tata Can provide summary page, but details should be viewed only
 - o Byrnes Only provide 990 or refer to Guidestar & nothing else
 - Wu agrees
- We currently have 70 referees who have completed registration process except SafeSport. They cannot be approved until SafeSport is complete. We have 76 referees who are pending Risk Management Officer Action for all reasons (including SafeSport). Still must complete NYWSYSA Risk Management process.
 - o Campbell Some referees have completed wrong course
- Total Registrations to be transmitted
 - 46 assignors
 - o 30 referees

- o 1 Instructor
- Some of our members with COVID-19
 - o RDYSL Proposed short season June 1-Aug 1
 - Roch Rec Leagues: Canceled
 - Thruway League: Canceled
 - o RDSL: No decision yet
- What to do about registrations if seasons are canceled? Request for refund?
 - Ross If they have completed course and been registered, money is spent and refunds would generate huge expense for state treasury. Almost no chance national will issue refunds
 - o Bianchi Reduced WNY portion of registration
 - Tata Discounted rate can be considered, but need to determine how to configure in OMS
 - Sustello Can we request local units help cover any refunds/reduction?
 - Wu What about refund on local dues? State does not have accurate records of local dues
 - Tata Units control local dues & could waive for 2021
 - o Referees who do not register for 2020 can return in 2021 without penalty
 - Pasnak We can only control our portion of registrations. Have to wait to see what US Soccer will do.
 - o Tata Could waive \$10 state maintenance fee for 2021

V. SYRA Report (Campbell)

- Thruway League meeting tomorrow will determine additional postponement to 30 Apr 2020.
- ODP All events canceled, still trying to determine what to do with President's Cup

• State Cup – Unlikely that final 4 will happen in May, but hoping to do something prior to deadline. Still need districts to submit names in case something does happen.

VI. SDI Report (Ross)

- Recert clinics several clinics have been canceled
 - Test clinic via Zoom went better than anticipated
 - Additional Zoom clinics have been scheduled with instructors experienced in online instruction. 6 have been scheduled, limit 20 participants. There can be exceptions made for overflow in specific circumstances
 - Instructions exist on OMS and in Tom's recent email on how to change into one of the online clinics
 - o List of clinics was emailed to SRC members
 - After each clinic, Ross will send participant list to all DRAs. Instructors do not have that ability

• Entry Clinics

- O Just over 100 new referee clinic registrations canceled. What do we want to tell those who have been canceled? Refunds? Move all to online?
- o 8 students participated in online class on 28 March
- Campbell Large fall league in southern tier where new referees can still work
- o Bianchi Be up front with referees about uncertainty surrounding games in 2020
- Pasnak Give referees a choice and set a date limit. Either complete course and risk no season or get refund
- Tata if refund, we keep the course fee (instructors/expenses) and refund registration/state maintenance
- Ross We will hold registrations until a deadline date. After that date,
 no refunds will be issued. (proposed date by Tata on or before May 10)

- If/when we start up in 2020, no changes anticipated to how/where we post assessments
- New assessors & assessor upgrades are on hold pending decisions from Chicago
