 - o Serrano: Can we continue to meet via Zoom? Tata: would prefer meeting in person when possible
 - o Pasnak: Can we do next meeting (Jan) by Zoom to give time to find suitable location? Tata: We will do Zoom for January 2021 and we will reconsider for April 2021

V. SYRA Report (Campbell)

- Changes happening at Regionals, State Cup, Thruway league no information available yet
- State Youth Referee of the year 3 male and 1 female applications Winner has been chosen but not yet notified. Will be announced at a later date.
- Tata has asked NYSWYSA to dedicate Youth Referee of the Year after Jonathan Solow, who passed away in 2020 at age 22. State has verbally agreed pending Jonathan's parents' approval. Also proposed a scholarship fund for Youth Referee of the Year winners. Winners would each be awarded \$500.

Those who do not plan to attend post-secondary education may choose a charity for donation of the funds

VI. SDI Report (Ross)

- Recert clinics Likely will be done online at this time
 - Usual facilities are not allowing outside groups to use space
 - Do not want to place burden on instructional staff to manage masks, social distancing, etc...
 - Will be training instructors to provide online seminars
 - Tata: Can we wait until 2021 to schedule recerts? Ross: We do not want to wait beyond January for scheduling concerns

• Entry Clinics

- Holding off on scheduling entry courses at this time, 70-80 new referees were certified online but none were able to referee.
- If online, prefer holding course as close to the season as possible (March, April and May if necessary)
- o Manadatory field training will be skipped if course is online

- Upgrade clinic no upgrade clinic currently scheduled dependent on numbers and public health situation
- SafeSport referees must update SafeSport prior to current SafeSport expiration in order to register
 - Pasnak request please include instructions on verifying SafeSport date in 2021 registration instructions
- Safe and Healthy Playing Environment course must be completed in Learning Center for re-registration. Content will be covered in Entry Level classes

VII. SDA Report (Jaspe)

- Grade 7 assessors and instructors will combine into Referee Mentor classification and must complete new coursework
- Regional Assessors must take coach course to get Referee Coach license
- 32 regional referees, 6 regional assessors, 2 national referee coaches Loss of 2 regional assessors in Rochester district
- Regional licenses will be valid until Coach program is established
