 - Last day for registration is April 30, 2022
 - New Referee courses can happen later if necessary at request of clubs/leagues. Clubs/leagues will be required to provide venue and dates, WNYSRA will provide instructors
 - Need to order Velcro, and order uniforms for Young Referee of the Year from Official Sports International
 - o Badges come from Campbell

- SRC Meetings for 2022
 - Venues are difficult to find
 - Campbell recommends staying virtual through 2022 based on budget & venue availability

V. SYRA Report (Campbell)

- State Cup Currently unable to discuss referee contract because match structure is not set. Meetings upcoming to attempt resolution
- Needs Young Referee of the Year nominees by May 1 in order to have all paperwork complete before students prepare for college – will send out email request to districts

VI. SDI Report (Ross)

- Recert clinics/training
 - Shared list of Basic/Advanced recert dates January dates are almost full. Many openings in February & March. Want to have recert classes done by end of March
 - Jason Byrnes question about referee who attended basic recert and wishes to attend an advanced recert. Tom Ross says he can attend providing all COVID protocols and health regs are observed

- Will add paid Zoom account if needed currently, WNYSRA only owns 1 paid account
- Attendees are heavily from 716 area code (Helwig: Many from Amherst Soccer Club)
- 4th Clinic will likely be scheduled 12 February

- Question on SafeSport Still issues with SafeSport refreshers about 50% of referees have had issues renewing SafeSport – US Soccer needs to fix integration with SafeSport in order for tie-in to Learning Center to operate properly
